

Lobby Day FAQ's:

When & where is Lobby Day 2024?

Wednesday, March 27th beginning at 9am in Convention Hall of the Empire State Plaza. For directions to the Empire State Plaza and parking information, visit this link: <https://empirestateplaza.ny.gov/>

Do I need to register for this event?

Yes. This allows us to keep you in the loop with updates, post meeting surveys, and lobbying reporting purposes. If you find you are unable to attend, just reach out to us at Govt@nysar.com and we can update our roster. Log in to your account on nysar.com. Is there a cost to attend?

No! Lobby day itself is a free event.

Are there any events I should know about around Lobby Day?

Yes! On Tuesday, March 26th RPAC is hosting a "Lobby Day Pre-Game" fundraiser at Apex Sports & Entertainment in Crossgates Mall from 5:30 pm – 9pm with Bowling, Laser Tag & Arcade plus a complete dinner buffet in a private room, 2 drink coupons per attendee included as well. The cost for this event is \$200. This event is preregistration only. The deadline to register is Friday, March 15th but this event is expected to sell out so don't hesitate to register. Proceeds from this event to benefit RPAC.

Will there be food and beverages available?

Yes. We will offer breakfast from 8am-10am, lunch from 11am-1:30pm.

Does NYSAR have Hotel Room blocks at local hotels for the evening of March 26th?

Yes, at the Renaissance Albany Hotel, Hampton Inn, and Hyatt. Please check out the Lobby Day section on nysar.com for more information.

Please note that just because you register for a hotel room, does **not** mean you are registering for the event.

Can I be reimbursed for my travel?

Yes. If you stay in one of our hotel blocks at the Renaissance, Hampton Inn, or Hyatt, we will deduct \$75 from the cost of your room PLUS you're eligible for an additional \$75. If you have planned to stay at another hotel, we're happy to reimburse up to \$150. For those making it a day trip, we will reimburse \$150 for miles/tolls/etc.

Reimbursement requests are valid until April 30th, 2024. So submit your request to Govt@nysar.com as soon as possible.

You are only eligible for this benefit if you've registered for the event.
